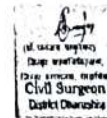

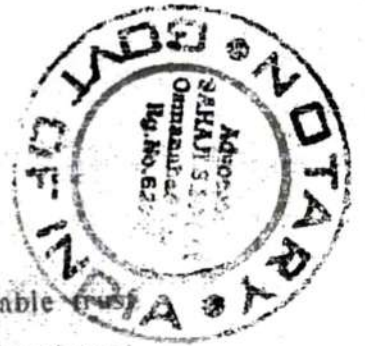

4. If he is punished moral crime

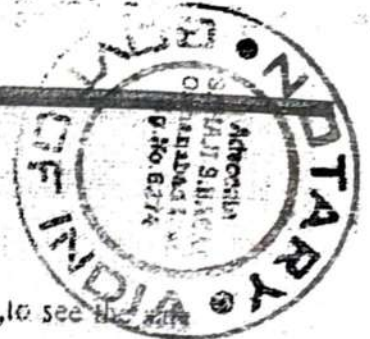

22. General assembly, its rights & functions

1. The general Assembly will be formed from all the members of trust, all the members of the trust can express their opinion in this assembly. The decisions taken in the assembly will be final and it will be unanimous.
2. The annual general meeting of the trust will be held within six months after the end of financial year of the trust.
3. The reports of the audits of the trust checked by the Chartered Accountant on time to time to the Asst. Charity Commissioner, sub division, Osmanabad.
4. To read the reports of the previous meeting, to grant the debts and credits, and budget put by the board of trustees
5. To discuss the subjects which come at right before the beginning of the meeting by the permission of the president of the General meeting and the subjects which are brought before the meeting by the trustees etc.

23. Special General Assembly & its functions.

30. The Sources/means Income.

The fees of membership, admission fees, donation and the income from the property Estate of the trust will be supposed as the means of the income.

31. Sale & purchase of the property & Estate.

To purchase necessary estates for the fulfillment of the objectives of the trust through the funds collected from the donations, debt membership fees or it sell un-necessary estates of the trust.

The arrangement will be made but for this purpose the trust will have to take the pre-emption from Mumbai Charity Commissioner under 1950 code No. 35/36.

32. Notices.

Any urgent routine matter (about the management of the trust) which is sanctioned unanimously trustees of the trust will be decided unanimously and if there is any controversy on the matter it will be put before the next meeting for the discussion & will be passed unanimously.

33. To make rules & Sub-rules.

By the scheme for the better/well management of the trust will make proper rules & subrules and the trust will have the rights of the implementation of the rules and sub-rules. But such rules & sub-rules will not be controversial to the provisions of the scheme & the Mumbai Public Charitable Trust and management. The trustees will take care of this.

The trust will have the rights of change or cancellation of the rules & sub-rules. Such changes will need the permission of ASSE, Commissioner Sub-Division, Osmaniaabad. The meaning of any code of the scheme.
